RECOMMENDATIONS

Communion / Anglican Alliance:

- To provide dedicated personnel to work with the UN and permanent Anglican representative to advocate for legislative change
- To maintain an overview of church and governments' policy and identify the challenges and opportunities for positive change
- To monitor and hold accountable for inadequate implementation

Provinces / Dioceses:

- Convince and equip leadership to recognize the priorities in terms of legislation and best practice
- To have constant monitoring to ensure that local projects and diocesan priorities are aligned.
- Diocese to implement partnerships at all levels of operation

Local churches:

- Prioritise education and awareness raising
- Provide pastoral care for victims/survivors
- Build micro economies as a sustainable alternative to trafficking.

Prevention and Participation

Communion/Anglican Alliance

- Launch a global public awareness campaign in partnership with other international churches and organisations. Engaging with governments to create greater impact.
- Reinforce the ACC resolution 15:10 and propose a more and inclusive plan with and urgent and practical action plan.

Provinces/Dioceses

- Mobilise all Anglican Provinces to issue a statement and make resolutions at their synods on supporting the anti slavery and human trafficking campaign.
- Ensure the implementation of a strategic prevention programme in every province and diocese.
 - Contextual Bible study
 - Survivor Movement

Local Churches

- Local churches to facilitate education and training programmes for the community aimed at prevention, including the most vulnerable groups in the community.
 - Youth ambassadors
- Mobilise the local churches to engage in antipoverty programmes in the community.
- Anglican Alliance to enhance the platform for information and resource sharing and resource mobilisation at local church level.

PARTICIPATION

Have clear guidelines at every level of:

- Social/behavioural change
- Attitudinal change
- Practical action

Create a group of Champions, including expertise from various areas, including survivor groups

Protection

Protection means ...

-No longer in slavery

-Vulnerability to being re-enslaved reduced/removed

No longer fear persecution by slavers and traffickers

Anglican Communion/Anglican Alliance

Provide training in conducting contextual assessment:

- local forms of slavery
- availability and gaps in resources and services

Guidelines in how to identify victims and activate resources and services to assist them

Investigate with partners the potential to create network of safe houses / fostering and resettlement network

Province/Diocese

- Support forum / networks for analysis about specific contextual issues on slavery/trafficking/migration
- Reflect on what is happening in our own context
- Support platforms for action with clear goals set

Local churches

- Create a culture of safe spaces in the churches
- What are skill sets of faith leaders to engage congregations – awareness, attitudes /beliefs, action
- Specific calls to action from local to global

Prosecution

Anglican Alliance

Identify strategic partnerships to and engage major bodies such as the UN, trade delegations, Interpol, and others to try to earn a seat on the review processes (those bodies that examine implementation of policies such as the UNODC, UN Women, Human Rights Council, Santa Martha Group, etc)

Diocese/Provinces

Link with strategic partners and engage with professionals within our Church to assist in providing training at appropriate state /federal levels for all law enforcement (judicial, investigative (Interpol, FBI), police, prosecutorial, defense):

- psychology and condition of survivors (ask the right questions)
- extent of the traffickers' operations (evidence gathering)
- education/awareness throughout the legal process

Parish/Local Churches

Link with partners and engage professionals within our churches to provide <u>training</u> at local level for all law enforcement

- psychology and condition of survivors (ask the right questions)
- the extent of local traffickers' operations (evidence)
- education awareness throughout the legal process

Educate/increase awareness within our congregations so that the public demands action, hold accountable officials responsible, and even serves as the eyes and ears of law enforcement.
