# Anglican Alliance working for a world.....



After two years of careful planning, the Anglican Alliance started its formal operations in January 2011. Episcopal Relief and Development has been closely involved right the way through.

In the past year we've consulted Episcopalians in all regions of the developing world to draw up our priorities and action plan, and to involve our partners in our work.

Our Latin America and Caribbean facilitator is based in Brasilia and has organised action on Rio + 20.

The Anglican Alliance has contributed to relief work in emergencies across the Communion and especially in Sudan, Japan and Pakistan. We've been a voice for the voiceless, supporting the church in Sudan and Burundi

Our capacity building includes a special distance learning course.

## Free of poverty and injustice

The Anglican Alliance works with churches and agencies to build capacity, co-ordinate and add value to the work that is taking place across the Anglican Communion.

Since our formal operations started in January 2011 we have taken part in joint missions with Episcopal aid agencies to Japan and Pakistan, where we helped to arrange for emergency repair work to flood-damaged homes in Peshawar diocese.

We also worked with the Episcopal Church and the presiding Bishop to press for improvements to global food security.

We are producing guidelines on how to manage emergency appeals and will be consulting on these very soon.

The Alliance is also bringing together

partners in Africa and Latin America to pursue their joint goal of increasing access to finance for the poor by scaling up micro-finance schemes.
