# Relief

Agreed to deal with emergencies in all countries, and natural and conflict related disasters.

**Modes of working** use of website, appeals by churches, virtual conferences, support for smaller appeals.

**Work with international relief agencies as well as church-based**

**Important role of regional facilitators**



## **Relief - focal points for Alliance**

**Disaster preparedness**

**Compiling of a database of skilled people and institutions**

**Support for people with disabilities/special**

**Development of expertise in providing a specialist service for people affected by emergencies, especially psycho-social support**

**Support for victims of gender-based violence in emergencies**
